Defendant, Indemnitor, Co-Indemnitor:

It is your responsibility to attend each and every court date and time.

As an Indemnitor or Co-Indemnitor you can lose all your collateral for a Defendant's Failure to Appear at Court. If we can no longer reach the Defendant, Indemnitor or Co-Indemnitor by phone the defendant will be returned to jail.

Violators List:

Mandatory defendants weekly walk-in office check-in fee \$20 dollars

If you are placed on the violators list for not completing your mandatory call-ins, walk-ins, and updating your court date/time, you will be returned to jail and a recovery fee of 15% or \$450 whichever is greater plus fees will be charged.
